100 Club Rules

PURPOSE

The purpose of the 100 Club is to raise funds for Wilsden Village Hall, a registered charity. The money will be paid into the Wilsden Village Hall bank account and used to meet funding necessities, including providing equipment, facilities and opportunities for the people of Wilsden and the users of the hall.

RULES

1. For a cost of £12 per year you will be allocated one number between 1 and 100.
2. A draw will be made every month with a 1st and 2nd prize.
3. The prizes will total 40% of the annual income.
4. This will be apportioned as: 1st prize of 25%, 2nd prize of 15%.
5. The 100 Club is a private lottery and is open only to users, parents, carers, staff and friends of Wilsden Village Hall. Anyone age 16 or over can join.
6. Club members may purchase as many numbers as they like.
7. Payments must be made by annual standing order or annual cheque. One month's notice is required for cancellation.
8. Members' numbers will only be entered if their subscription is up to date.
9. If a member has no valid reason for missing a payment, their number may be sold to someone on the reserve list.
10. The draw will be made by the chair of the Wilsden Village Hall Management Committee in their meeting each month and announced immediately.
11. If for any reason no management committee meeting is scheduled to take place that month, the number will be drawn by the hall manager in the presence of staff.
12. The winning cheque will be posted to the address on your membership application by the end of the month in which the draw takes place.
13. The names and numbers for each month's winners will be posted on the village hall website and Facebook page.
14. The 100 Club will be run by the Wilsden Village Hall Management Committee. In case of any dispute the decision of the committee is final.
15. Unless otherwise advised, a member will be deemed to have left the 100 Club if his/her subscription renewal remains unpaid for a period of one month.
16. If a winner cannot be contacted, the winnings will be placed into Wilsden Village Hall funds after six months.
17. These rules may only be amended by the management committee of Wilsden Village Hall.
